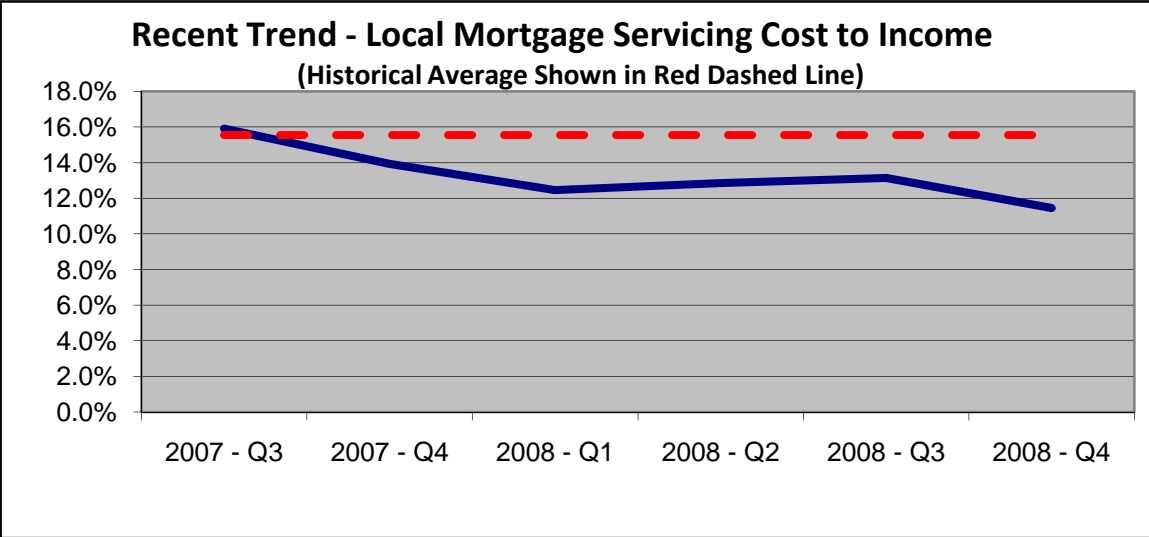

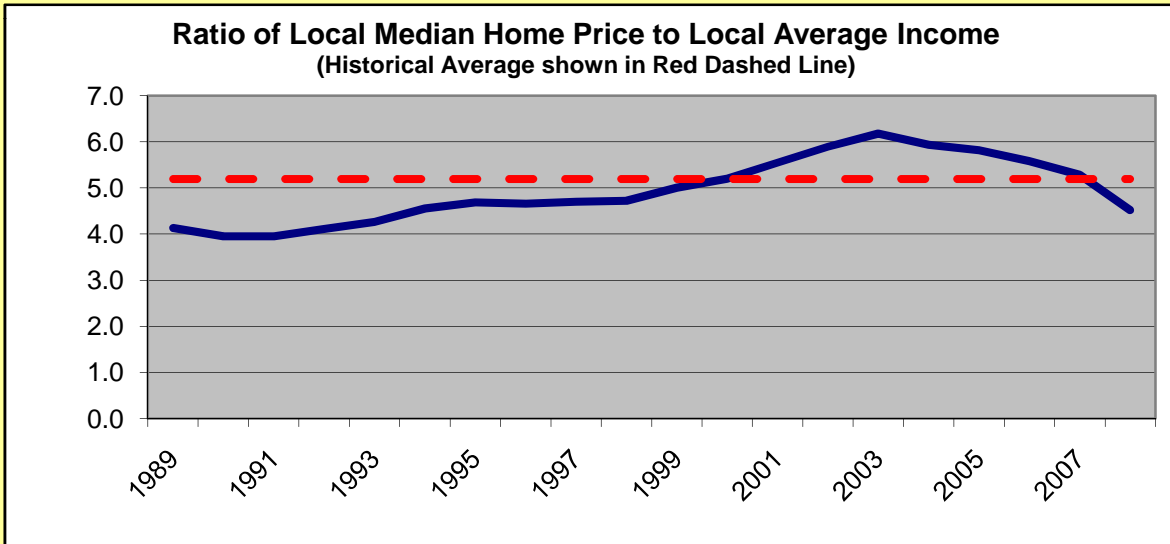
**Rolling 12-month sum vs. a year ago



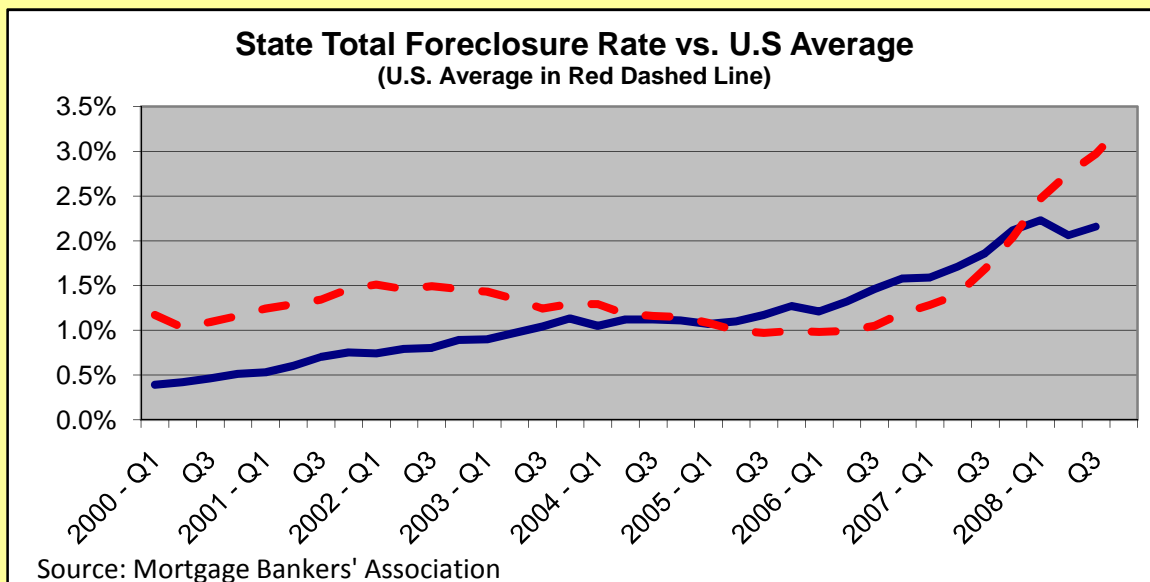

TOTAL Foreclosure + REO Rate	1.2%	1.2%	There has been a large local increase versus a year ago
TOTAL Foreclosure + REO Rate (same period, 1-year earlier)	0.9%	0.5%	The current local rate is high compared with the current U.S. average
SUBPRIME Foreclosure + REO Rate	10.1%	14.0%	There has been little change locally compare to year ago
