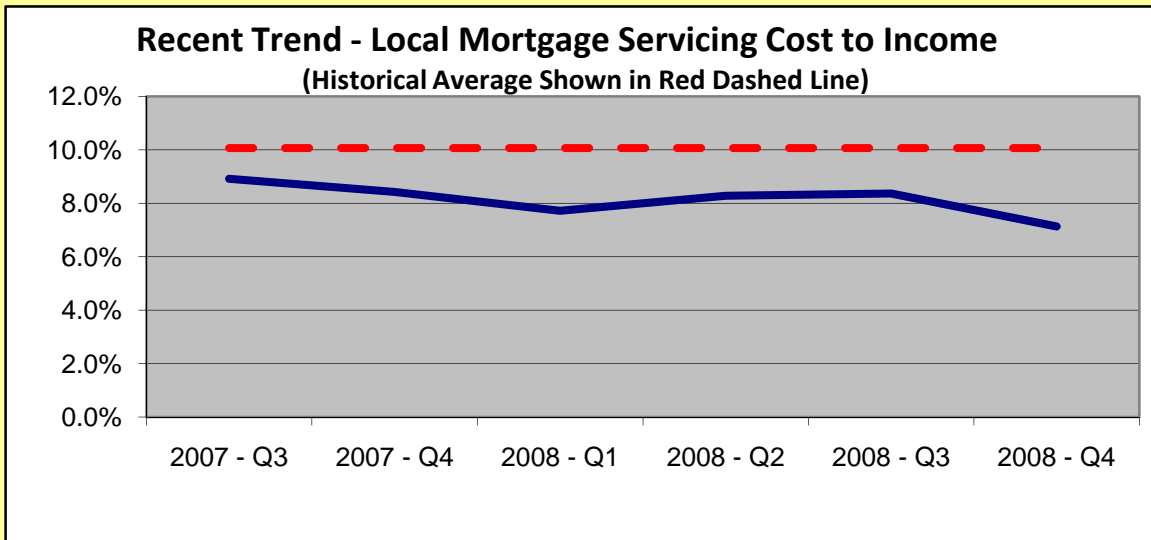

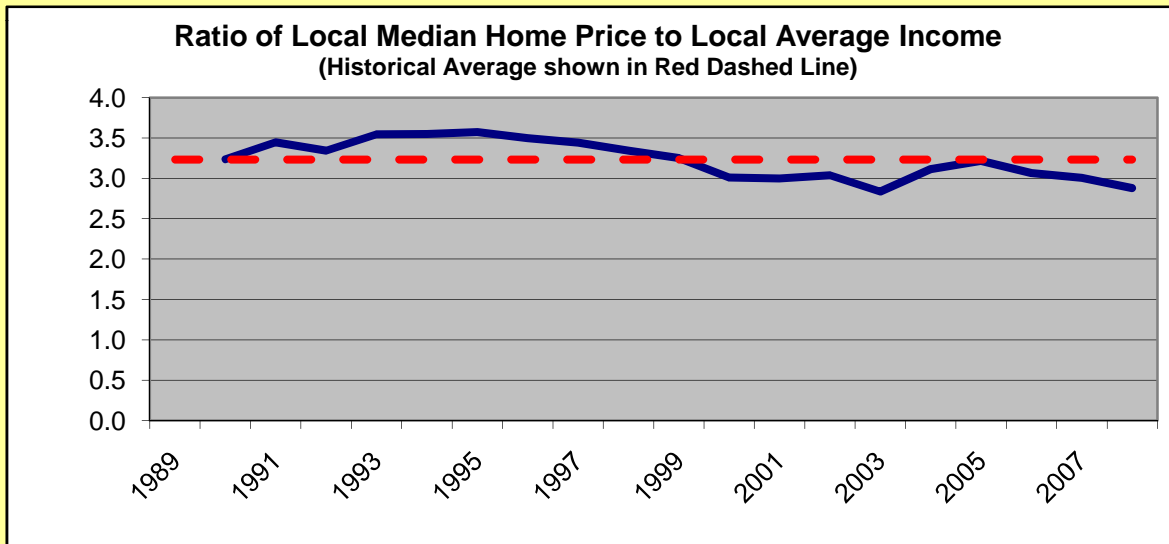
**Rolling 12-month sum vs. a year ago



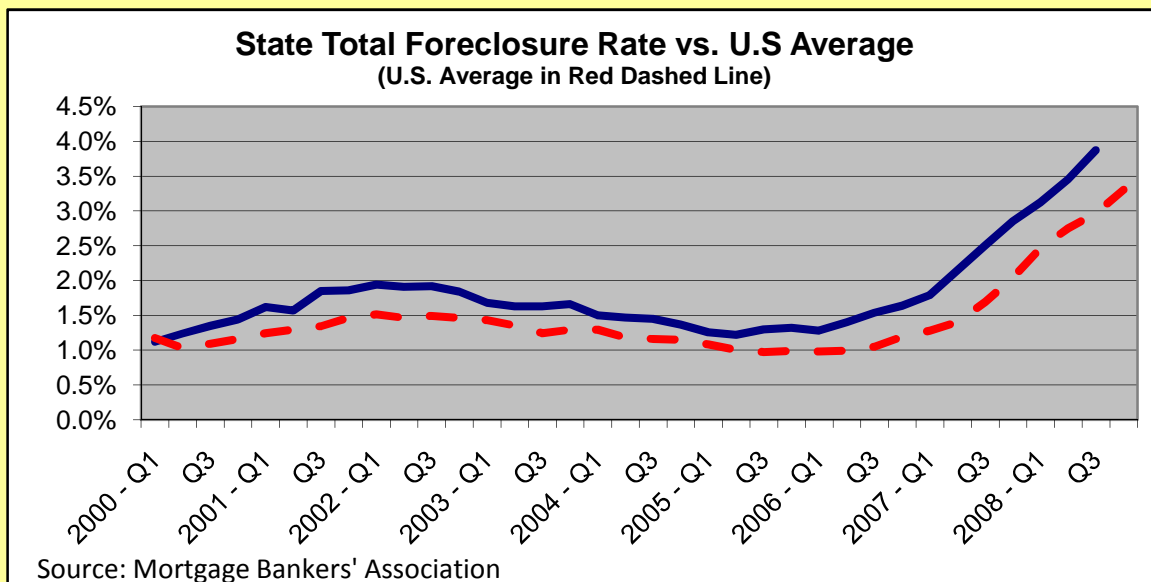

PRIME Market Share	93.3%	84.2%	Lower subprime exposure than average
SUBPRIME and Alt-A Market Share	6.7%	15.8%	Strong Compared to the Nation
TOTAL Foreclosure + REO Rate	0.7%	1.2%	There has been a large local increase versus a year ago
TOTAL Foreclosure + REO Rate (same period, 1-year earlier)	0.4%	0.5%	Compared to the national average, today's local rate is low
SUBPRIME Foreclosure + REO Rate	10.1%	14.0%	There has been little change locally compare to year ago
SUBPRIME Foreclosure + REO Rate (same period, 1-year earlier)	8.6%	7.2%	The current local rate is high given the current U.S. average
